### 5.2 Finance Report

#### D Hill (The School Office) Finance Report Update:

- Operational Grant currently on track (75% funds received to date)
- Annual results tracking well- due to unbudgeted MOE funds we've received (settlement funds etc)
- Local funds the school has received lots of local funding due to funding such as Active As and Carbon Farming
- Trading is ahead of budget also
- Expense wise, most budgets are tracking well such as the teaching salaries and support staff.
- Administration expenses 63% under budget when comparing to this time last year.
- Auditors fee 2024-26 will be out soon.
- Property tracking well. The repairs and maintenance expenses are within budget. You need to review the Cyclical Maintenance Plan and how that's going to look moving forward. How the stadium overheads/maintenance will intergrate into this. What are the expectations of the school to be involved in the maintenance of the gym/rec centre.
- Capital Expenses Budget This budget has been spent or close to it. Any further purchases need to be minuted by the board.
- Uncommitted Funds tracking very well. The Principal asked if there is a formula to
  calculate the amount of Uncommitted Funds a school should retain or a per student rate?
   D Hill replied that it is variable between schools. Some say \$800-\$1000 working capital per
  students however there is nothing specific from the Ministry. The School need to set a
  target and create a rainy day fund. It is worth a discussion with a couple your Ministry
  finance advisor.
- G Williams Follow up on the Uncommitted Funds & Term Deposit Top-up

- Cyclical Maintenance to mitigate inflation rate costs
- Banking staffing underspend
- Support Staff under budget
- There are some things over budget L Taylor will review these to ensure they are coded correctly
